# Charter Appendix

Editor's Note: Set out herein is the latest Charter of the town as amended. The charter act did not repeal any prior acts, but superseded conflicting provisions of prior acts. Prior charters and acts in the nature of charters are as follows, in reverse chronological order: Priv. Law 1873-74, Ch. 112, an act to incorporate the town; Laws 1858-59, Ch. 211, extending to the town the provisions of Ch. 111 of the Revised Code, and designating the district constable as the town constable; Laws 1854-55, Ch. 252, providing for opening the polls, voter eligibility, powers of commissioners, and the like, and repealing all acts of incorporation and acts to revive such acts; Laws 1850-51. Ch. 337. to revive Laws 1842-43. Ch. 30; Laws 1842-43, Ch. 30, incorporating the town; and Laws 1773, Ch. 22, establishing "a town on the land of Isaac Jones, on the South West side on the North West Branch of Cape Fear River, In Bladen County," by the name of "Elizbeth Town." For related laws not constituting charters or charter amendments, see the Charter Appendix.

# SEC. 1. TOWN INCORPORATED; CORPORATE NAME AND POWERS.

The Town of Elizabethtown, in the County of Bladen, be and the same is hereby incorporated, by the name and style of the Town of Elizabethtown, and shall be subject to all the provisions contained in Chapter sixty-two (62) of Volume two (2) of the Code not inconsistent with this act. (Priv. Laws 1895, Ch. 156, §1)

Editors' Note: Presumably, the subject matter of "Vol. 2 of the Code" to which reference is made would now be encompassed in G.S Ch. 160A.

## SEC. 2. CORPORATE LIMITS.

The corporate limits of the Town of Elizabethtown shall be as follows: Beginning at an iron stake or marker in the western line of the tract of land leased by Clark-Shaw Ford, Inc., or for said business on the southwest side of N.C. Highway 87, said beginning point being particularly located south 43 degrees, 26 minutes, 46 seconds west 30.045 feet to the southwestern right-of-way margin of said highway, south 49 degrees, 44 minutes, 11 seconds east 121.12 feet with the southwestern edge of said highway; and south 40 degrees, 15 minutes, 49 seconds west 200.0 feet from N.C. Grid Coordinates x = 2108212.976 and y = 324521.989, and running thence from said beginning point so located the following courses and distances:

## SEC. 2.1. FORM OF GOVERNMENT.

The Town of Elizabethtown shall operate under the Council/Manager form of government in accordance with Part 2 of Article 7 of General Statutes Chapter 160A. (Ord. passed 10-1-90)

### SEC. 3. TOWN OFFICERS.

The officers of said town shall consist of a Mayor, six (6) Councilmembers, a Police Chief, regular and special policemen, and a Clerk and

Finance Officer, and such other officers as the Town Commissioners may elect. (Ord. passed 1-10-79)

## Editor's Notes:

This section is formerly derived from Priv. Laws 1895, Ch. 156, § 3; Priv. Laws 1899, Ch. 134, Ord. 04-03, passed 4-5-04, provides that the Mayor and Town Council members shall be elected using the nonpartisan plurality method of election as set forth in G.S. § 163-292. The ordinance, while providing that this Charter section is to be so amended, did not set forth the specific amendatory language.

### SEC. 3.1. TERM OF MAYOR.

The term of the office of Mayor of the Town of Elizabethtown shall be four (4) years. (Ord. passed 2-1-82)

# SEC. 4. ELECTION OF OFFICERS BY TOWN COUNCILMEMBERS; APPOINTMENT OF SPECIAL POLICEMEN BY MAYOR.

The Town Constable, Clerk and Finance Officer and regular policemen shall be elected by the Town Councilmembers and special policemen shall be appointed by the Mayor.

## SEC. 5. QUALIFYING BY OFFICERS.

Officers provided for by this act shall qualify within ten (10) days before a justice of the peace or

the clerk of the superior court, and all officers hereafter elected shall qualify in like manner. (Priv. Laws 1895, Ch. 156, § 5)

# SEC. 6. POWER OF TOWN COUNCIL TO MAKE LAWS AND PASS ORDINANCES.

The Town Council shall have power to make all necessary bylaws and pass ordinances not in conflict with the laws of the state. (Priv. Laws 1895, Ch. 156, § 6)

# SEC. 7. PAYMENT OF FINES INTO TREASURY.

All fines collected shall be paid into the treasury of the town for the benefit thereof. (Priv. Laws 1895, Ch. 156, § 7)

### SEC. 8. EFFECTIVE DATE.

This act shall be in force from and after its ratification. (Priv. Laws 1895, Ch. 156, § 8)

Editor's Note: The act was ratified on March 11, 1895.

# SEC. 1. AUTHORITY TO SELL PORTION OF BEN STREET.

The Board of Commissioners of the Town of Elizabethtown is authorized to sell at public auction for cash that portion of Ben Street in the Town of Elizabethtown extending east from Broad to Queen Street or any part of the same which it may deem to be in the best interest of the town. The notice of the time, place and terms of such sale shall be published in a newspaper published in Bladen County once a week at least four (4) successive weeks immediately preceding the date of sale. The sale of property herein authorized shall not be concluded and the bids shall remain open for a period of ten (10) days during which time the Board is authorized to receive an upset bid as provided in G.S. § 1-339.64, and in case an upset bid is filed as therein provided, a resale or resales of said property shall be had in accordance with the provisions of G.S. §§ 1-339.64 to 1-339.66 inclusive. After confirmation of the sale of said property by the Board, the town is authorized to execute a fee simple deed to the purchaser or purchasers and apply the proceeds from the sale or sales in such manner as may be deemed for the best

interest of the town. (Sess. Laws 1955, Ch. 106)

# SEC. 2. AUTHORITY TO ABANDON AND SELL PORTIONS OF POPLAR STREET, QUEEN STREET AND HAVERFORD STREET.

- (A) The governing body of the Town of Elizabethtown be and it hereby is authorized to abandon such portion of Poplar Street in said town from its intersection with Broad Street to the Cape Fear River at the old ferry landing, as the governing body may find to be unnecessary for the public use, Queen Street and Haverford Street from Poplar Street to the fill and bridge across the Cape Fear River.
- (B) The governing body of the Town of Elizabethtown be and they are authorized to sell those portions of the said street set forth in division (A) above at public auction for cash after giving notice of the time and place of sale at the courthouse door of Bladen County for thirty (30) days immediately proceeding the date of the sale, and by publishing notice thereof once a week for four (4) weeks preceding the date of the sale in the Bladen Journal, a newspaper published in Bladen County, and to convey the same to the purchaser or purchasers by deed in fee simple.

# SEC. 3. TOWN DECLARED A BIRD SANCTUARY; ILLEGAL ACTS THEREIN.

- (A) The territory within the corporate limits of the Town of Elizabethtown in Bladen County shall hereby be declared a bird sanctuary.
- (B) It shall be unlawful for any person to kill, trap or otherwise take any bird within the corporate limits of the Town of Elizabethtown, except English sparrows, great horned owls, Cooper's hawks,

sharp-shinned hawks, crows, starlings, pigeons and domesticated fowls. Any person violating the provisions of this sec-tion shall be guilty of a misdemeanor and upon convic-tion shall be fined not more than fifty dollars (\$50.00) or imprisoned for not more than thirty (30) days. (Sess. Laws 1957, Ch. 109)

*Editor's Note:* G.S § 14-4 now permits punishments of up to \$500/30 days.
