Park Reservation Procedures

Activities sponsored by the Town of Elizabethtown have priority in scheduling for use of all parks. Admission cannot be charged for entrance into a Town of Elizabethtown operated park. Park facilities may be reserved for a maximum of 4 hours; reservations must end by dusk. Profit-making or fund-raising activities are not allowed within Town parks. Alcoholic beverages, illegal drugs, or weapons are prohibited; except to the extent that concealed weapons are allowed by law. Concealed weapons are not allowed in the vicinity of ball fields, playgrounds, trails or greenways. The park must be left clean and in orderly condition. Return of deposits will be determined by the condition of the park when inspected. Reservation agreements must be signed by persons 21 years of age or older. The person signing the reservation agreements must ensure that appropriate adult supervision will be on site if the reservation involves activities for youth.

Park Reservation Confirmation Process:

Inquire about park availability with the Town of Elizabethtown: 910-862-2066.

After availability is confirmed, submit a completed Park Use Permit and payment at the Town of Elizabethtown, 805 W. Broad Street. Cash, credit/debit card or check payable to the Town of Elizabethtown accepted. (An additional \$2.50 fee will apply if using a credit/debit card.)

You will receive a confirmed copy of the Park Use Permit for your reservation at time of payment. You <u>must</u> have your confirmed Park Use Permit with you during your park reservation.
